## COMMUNICATING "GOOD MEDICINE"

### New consumer publication seeks physician-authors



*MedFocus links CMS members with community*

CMS HAS AGREED to collaborate with a new Chicago-area consumer magazine, *MedFocus*, to offer medical information from local physicians directly to the public.

CMS encourages its members to provide "good medicine" by submitting articles to the publication. All physician-written articles will be accompanied by the author's photo, making the doctor's face familiar to patients in the community. (See last paragraph in this story for more author details.)

Monthly topics will cover the latest medicines, treatments, alternatives and cures. A section called "Ask the Doctor" will be written by a series of physicians whose special-

ties are related to the monthly topic. *MedFocus* also will include a directory of local physicians and health-care facilities. And there will be a section called "Healthy Living," offering recipes for delicious foods that promote good health.

The monthly publication will be available free to consumers at more than 200 locations throughout Chicago, including Jewel-Osco, Dominick's, Bally's, Blockbuster and K-Mart, as well as hospitals and health-care facilities.

*The first issue will be launched in March 2001; you can pick up your premier copy at the Midwest Clinical Conference, Feb. 22-25, at Navy Pier.*

*MedFocus* is a joint venture between Pathways 2000, a publisher with more than 40 years of medical and health-care experience, and Target Advertising Group, Inc., a local marketing company.

CMS will appoint an editorial advisory panel of physicians to review articles for accuracy and appropriateness.

## FROM THE OFFICE OF THE INSURANCE OMBUDSMAN

### Insurer blocks payment; IDI to investigate

*An interesting twist in the complicated world of billing*

THE ILLINOIS DEPARTMENT OF INSURANCE is now reviewing a case sent to it by the office of the CMS insurance ombudsman.

The situation involves a member physician with a private practice who also works at a clinic in a local teaching hospital. The trouble began last September when the Kentucky office of a major insurer stopped making payments.

When the billing staff investigated the problem, they discovered the insurance company had replaced the physician's corporate ID number, the number used for all of his private office billing, with the billing number the university hospital used for his clinic patients, and redirected payment accordingly.

Although the physician's staff finally untangled the puzzle, and the insurance office agreed to correct the problem, it never did. The insurer continued to replace the physician's corporate billing number with the university hospital's number, in spite of numerous calls and letters.

When CMS discussed the matter with officials from the Illinois Department of Insurance, they expressed interest in investigating and requested a written complaint from the physician's office. The physician has supplied the information, and we'll keep you advised of the outcome.

## EARNING REVENUE

### CMS to rent out first floor



The first-floor meeting space, site of many CMS programs, will soon be rented out to earn income for the Society.

IN AN EFFORT TO OFFSET DECLINING membership revenues, CMS has set mid 2001 as a target date to rent the under-used first floor of the medical Society building.

The first floor meeting space, which comprises 5,000 square feet, is currently used for Council meetings six times a year, monthly board and executive committee meetings, and occasional professional meeting events.

Rental income for the space is projected at anywhere from \$175,000 to \$200,000 yearly.

Renting the first floor would lower CMS' office cost to \$1.24 per sq. ft., down from \$8.28 per sq. ft.

Council meetings will be relocated to another site, possibly Maggiano's Restaurant, two blocks west of the CMS building, or to a local hospital. Catering and parking costs would remain the same. CMS will also make greater use of existing office space in the basement by remodeling areas for use as meeting facilities. Most staff offices are now located on the second floor.

CMS purchased the five-story 515 N. Dearborn building in 1978 from the Worsham College of Mortuary Science and currently rents three floors to local businesses.

### What issues would you like to see discussed at the ISMS House of Delegates meeting in April?

DURING THE LAST COUNCIL MEETING (Jan. 9), *CMSnews* staff asked several members to answer the question above. Here are their comments:

**Wolf Peddinghaus, MD**

*General internal medicine and gerontology*

"We need collective bargaining. Most of us have seen a complete erosion in the care we can provide. We need a counterbalancing influence against excessive government regulations and managed care."

**Joan E. Cummings, MD**

*Internal medicine and geriatrics*

"I would like to know how CMS and ISMS are going to respond to the AMA's proposal to restructure itself with representation by organization rather than by individual. Physicians would be AMA members by virtue of the specialty or state/county society to which they belong. I think the AMA proposal makes sense."

**Dennis Malecki, MD**

*General surgery*

"There are three issues. The quality of care being affected by staffing and shortage of beds. Another area is glitches in reimbursement, especially with Medicare and HMOs. Last is malpractice. We must bring that beast under control. Our malpractice rates are increasing and our reimbursements are going down. The [time-consuming] part of 'doing business' is impacting our practice of medicine."

## CLEARING THE SMOKE

### “All for Health” to weigh in on tobacco settlement

THE ALL FOR HEALTH COALITION HAS PROPOSED the establishment of a Tobacco Settlement Recovery Fund. Monies would be used exclusively to promote tobacco cessation and prevention and to improve the health of Illinois citizens.

CMS is a member of the Coalition, a group that aims to convince the state of Illinois to allocate 100 percent of future tobacco settlement proceeds to health-care concerns.

The coalition also is comprised of major health care professional, public health, and nursing organizations in the state along with the deans of Illinois medical schools.

The Coalition’s proposal would channel the funds into four areas:

- Tobacco prevention and cessation
- Local public health efforts
- Medically underserved programs
- Biomedical research

The Illinois State Medical Society, also a mem-

#### ***Who’s funding tobacco prevention programs?***

Only six states--Arizona, Indiana, Maine, Massachusetts, Minnesota and Mississippi--are funding tobacco prevention programs at “minimum levels” recommended by the Centers for Disease Control and Prevention. The CDC recommends that states use approximately 20 to 25 percent of their settlement funds to establish cessation and prevention programs--*Findings from a new report issued by the Center for Tobacco-Free Kids*

ber of the Coalition, is aiding with draft legislation that the Coalition will take to state legislators, the media and to constituent organizations.

Illinois is one of only two states to use a portion of its tobacco settlement funds for non-health-related projects.
