## MEDICAL COMMUNITY "STANDS UNITED"

### ***Getting the liability message out in the media***

CMS MEMBERS WERE AMONG THE 15 leaders of state and local medical groups to sign a letter to *Crain's Chicago Business* supporting the Illinois State Medical Society's efforts to solve the medical liability and litigation crisis. The letter, which appeared in the Aug. 2, 2004, issue, praises ISMS-led efforts to defeat a sham "asset protection" proposal introduced by the Illinois Trial Lawyers Association that would require settlement of all suits filed.

Answering the trial lawyers' suggestion that ISMS does not, in fact, represent Illinois physicians and how, in the words of attorney Robert Clifford, physicians need to be

made aware of "how their purported lobbyists actually are working against their interest in Springfield," the authors wrote: "Make no mistake: The medical community stands united with the Illinois State Medical Society and its efforts to bring sanity to our litigation system and preserve access to health care for Illinois citizens."

On another front, CMS President Peter E. Eupierre, MD, and Executive Director James R. Tarrant, CAE, co-authored a pro tort-reform essay this month for *Chicago Image Magazine*, a consumer magazine dedicated to informing, entertaining and educating Chicagoans about health, medical and wellness issues. ### Tort reform -- Is it "useless" to talk to legislators?

"WHY EVEN BOTHER TO TALK TO LEGISLATORS about tort reform? Nothing will be done until so many doctors are forced to leave the state that people start dying from lack of care."

That pointed remark was made by several physicians at the CMS Branch Presidents' Meeting on Aug. 5. And unfortunately, this pessimistic view is common among many physicians.

Yet nothing could be further from the truth. Something can be done--and is being done:

- CMS has hosted two separate rallies at Daley Plaza and the Federal Building. We have delivered petitions to Senator Durbin and Governor Blagojevich, held meetings with legislative representatives, sent letters to the editor, provided op-ed pieces to the media, and collaborated with the Chicago City Council.

- This fall CMS will roll out "Access to Care Rallies" and host monthly legislative breakfast meetings. CMS is currently working with hospitals to plan rallies in various regions of Cook

County, and host legislative Branch breakfasts and other meetings where physicians can meet face-to-face with politicians and discuss the impact of the medical liability crisis within each community.

- ISMS has just completed a marathon session to resolve Illinois' medical liability crisis. The state organization supported and promoted Senate Amendment 5 to HB 4847, and House Amendment 5 to SB 2239. The bills included changes to Illinois' litigation system to reduce the number of frivolous lawsuits filed against physicians and protect physicians' personal assets. It also enhanced medical discipline and increased regulation of malpractice insurance companies. ISMS also led efforts to defeat a sham "asset protection" proposal introduced by the Illinois Trial Lawyers Association. The efforts of ISMS leadership will be crucial this fall when state lawmakers reconvene.

## CAPS GAIN SUPPORT

### ***Change comes slowly--Perseverance, patience and persistence are key***

AN INCREASING NUMBER OF ILLINOIS STATE lawmakers now support caps on non-economic damages. Public opinion polls also show that the public has begun to understand the significant adverse effect that an out-of-control system is having on access to care in the communities.

But this shift in thinking did not come overnight. It came through the tireless efforts of physicians, acting individually and speaking through their advocacy organizations, to make this progress.

*Some say it takes seven years to shepherd a new law through the legislature.* Let's look at some typical legal journeys:

In Texas, civil justice reform didn't come easily. The state, which passed an amendment to its constitution last September, passed tort reform legislation in 1977, only to see it struck down in 1988 by the Texas Supreme Court as unconstitutional. In Illinois, legislation providing for caps, a review panel, and loser pays law passed the legislature in 1975, only to be declared unconstitutional by the Illinois Supreme Court in 1976. In 1985, legislation providing for attorney contingency fees, pre-trial screening panels, a loser pays policy, structured verdicts, affidavit of merit, abolition of punitive damages and collateral source offset passed the legislature. In 1995, the legislature passed a limit of \$500,000 on all non-economic lawsuit awards. This and other effective litigation reforms were declared unconstitutional in 1997.

The battle to remove physicians from the execution process was also a long-fought-for triumph. In 1991, Illinois passed a bill requiring the presence of at least two physicians in lethal injection executions and requiring that they pronounce death. The bill was strongly opposed by CMS, ISMS, and AMA, along with other health and humanitarian groups.

Following this professional outcry, in 1992 Illinois amended the law to remove the mandated witnessing role for physicians but kept intact the provisions about pronouncing death and anonymity. In 1993, the Justice Department eliminated those requirement, but it still did not prohibit physician participation in executions. Each year CMS, through ISMS, supported legislation to explicitly exclude health professionals from the execution statute, reverse the amendment of the Illinois State Medical Practice Act, and revoke the secrecy provisions as they relate to health professionals. For many years, this legislation languished in the rules committee and was not released for general debate in the senate. Finally, after years of controversy, legislation was enacted banning physicians from the execution process.

Making inroads takes time. Your membership and support are crucial to a successful outcome.

## TESTIMONY EXPOSES CONCERNS

# ***CMS voices opinion on mandatory HMO enrollment of Medicaid-eligible patients***

*"PHYSICIANS IN COOK COUNTY ARE concerned about access to health care for the people of Illinois, and members of the Chicago Medical Society are very anxious about the impact of mandatory HMO enrollment of Medicaid-eligible patients into the fragile health care system."*

So read a statement prepared by CMS and presented to the state's Medicaid Managed Care Task Force (PA 93-674) meeting on Aug. 9 at the Thompson Center.

Your Society is concerned. CMS gave testimony stating that before implementing an expanded Medicaid managed care program, the state must undertake careful study of all options and assess the impact on access and quality of care.

Here is a summary of that testimony, the first in what CMS plans as a series of statements addressing a mandatory program:

"In Cook County the potential impact of further reductions in reimbursement to physicians who are marginally able to remain open and on the edge of leaving the practice of medicine or moving to another location will significantly impact access and quality of health care. Many physicians are reportedly practicing at the margin already. The loss of only a few physicians in underserved areas of the city or county could also affect the viability of some hospitals serving those communities."

In July 2004, the Illinois Department of Public Aid (IDPA) described pharmaceutical spending as the cost driver for Medicaid budget growth. CMS believes that any consideration of moving Medicaid into managed care must carefully examine how this plan will reduce expenditures for drugs without reducing access to physicians.

IDPA also says that, "Under a voluntary managed care program, clients waive the right of freedom of choice in exchange for the benefits provided by a guaranteed network of providers." The Chicago Medical Society welcomes the opportunity to work with the Medicaid Managed Care Task Force in determining how many physicians would be willing to participate in such a program with declining reimbursements.

The fact that surrounding states with higher levels of Medicaid managed care programs have adopted medical liability reform and are the same states where Illinois physicians are moving their practices must be considered before any action to channel patients to fewer and fewer participating physicians.

According to the CMS testimony, the Illinois OB/GYN Crisis Coalition has reported that one physician said the loss of physicians performing obstetrics is increasing his practice volume, and that this influx allows him to choose patients, thus reducing the number of Medicaid patients his practice will accept.

In concluding its testimony, CMS said that the proposed Medicaid expansion in Illinois will pay too little attention to quality and access to care. The long-term impact will be loss of physicians and a shortage that will take years to overcome.
