### ***CMS launches Senior Physician Group***

THE CMS COUNCIL HAS PASSED A resolution calling for the establishment of a Senior Physician Group (SPG). Proposed by Joseph L. Murphy, MD, CMS past president and councilor from District 2, the resolution calls for the group to be composed of CMS senior physicians who are emeritus, retired or practicing physicians, age 60 and older.

SPG goals are for these physicians to become meaningfully involved in CMS, participating in such activities as physician recruitment, outreach, education and legislative endeavors. The new physician group will also seek to establish a beneficial

affiliation with both ISMS and the AMA, which already has its own senior physician group, of which Dr. Murphy is a current member.

Such affiliation will allow CMS senior physicians more opportunity to become involved in lobbying, and more access to CME travel programs, along with the chance to share their considerable expertise with their CMS colleagues. Dr. Murphy said he looks forward to collaborating with Highland Park physician Albert J. Miller, MD, who is a former chairman of the AMA Governing Council, and a member of the AMA's Senior Physician Group.

### ***CMS resolutions adopted at the HOD***

- **Support for Center for Health Policy and Law**  
Comprised of the University of Illinois at Chicago College of Medicine and the Institute of Government and Public Affairs at the University of Illinois at Champaign-Urbana

Adopts policy to support, in principle, the development of a Center for Health Policy and Law comprised of the University of Illinois at Chicago College of Medicine and the Institute of Government and Public Affairs at the University of Illinois and other interested academic institutions, with representation of ISMS; reaffirms ISMS' health policy leadership role as an advocate for Illinois patients and physicians.

- **Medicare Reduction in Graduate Medical Education Payment**

Endorses and supports the position of the AAMC to recommend against any further reduction in Medicare financial support of graduate medical education; works with the Illinois Hospital Association and all Illinois hospitals with graduate med-

of standard health care benefit packages that are evidence-based, including preventive services and appropriate emergency services; forwards this resolution to the AMA for introduction and support at the national level; requests AMA or a consortium led by the AMA, to develop models of benefit packages that could serve as templates to guide insurers in designing health care benefits.

### ● **Support of Sudden Infant Death Syndrome (SIDS) Research**

Initiates or supports allowing medical examiners and coroners to take tissue samples, to the extent permissible by law, for research purposes from infants who have died suddenly and unexpectedly with consent of the responsible adult if the tissue is not likely to result in any visible disfigurement; brings a similar resolution to the AMA's next annual meeting.

### ● **Reducing Trans Fats**

Strengthens language in ISMS policies on nutrition calling for the Society to encourage and promote the reduction of trans fats in the American diet in order to maintain good health and lower the incidence of coronary artery disease; issues a statement encouraging and promoting the reduction of trans fats in the American diet; brings a similar resolution to the AMA's next annual meeting.

### ● **Toy Safety**

Supports legislation that would strengthen the

national toy safety guidelines, encourages manufacturers to more closely regulate the design and sale of their products, and further expands educational campaigns to raise awareness among parents; forwards this resolution to the AMA to initiate or support national legislation aimed at improving safety; requests the AMA to adopt policy calling for improved toy safety guidelines as well as encouraging manufacturers to more closely regulate the design and sale of their products and further expand educational campaigns to raise awareness among parents.

### ● **Nursing Home Abuse and Neglect**

Adopts policy that recognizes elder abuse and maltreatment in nursing homes as a continuing problem, and that further supports comprehensive steps to reduce its incidence; supports passage of legislation that would help prevent elder abuse in nursing homes and gives consumers more information to guide nursing home placement; brings a similar resolution to the AMA's next annual meeting.

### ● **Reasonable Delay in CME Completion**

Requests the IDFPR to work with ISMS to spell out viable alternatives to non-renewal status, including inactive status; provides a directory of free in-state CME resources, particularly for doctors unable to travel, to include journals and Internet courses, among others, so they can comply with Illinois law.

MANY ILLINOIS RESOLUTIONS, INCLUDING those sponsored by CMS members, are bound for the AMA House of Delegates meeting in June. Their journey attests that a county medical society can help shape and influence the national health care agenda and the medical profession's stand on emerging health care issues.

Adding to the local perspective is the fact that former CMS member and Chicago native, Ronald M. Davis, MD, will be inaugurated as 162nd president, replacing outgoing President William G. Pledsted III, MD.

Major topics this year include human rights, Medicare Advantage, physician health, the physician quality reporting initiative, women physicians' congress, and health information technology.

## ***Cook County shuts down computer referral system***

THE COOK COUNTY BUREAU OF HEALTH Services is suspending the use of a referral system that had helped thousands of needy patients get specialized medical services at Cook County. The sophisticated computer referral system had allowed private clinics to refer patients to Stroger Hospital's specialty clinics. Based on information from the private physicians, the system had approved patient appointments and ranked them in order of urgency.

But due to budget cuts, patients from private clinics now must go to a single county walk-in clinic near Stroger to get referrals. (The walk-in clinic reduced its hours by almost one-third earlier this year.)

Members of the medical community are alarmed.

As reported in the *Chicago Tribune*, some say the new arrangement, in addition to aggravating already long waits, will force patients into consultations with County doctors who have no knowl-

edge of their medical histories and who will need to reorder tests. According to CMS member Lee Francis, MD, the health bureau "will incur the expense of hundreds if not thousands of additional ambulatory visits."

Critics see it as a way to cut access to the specialty clinics.

The announcement follows the recent decision to close more than a dozen County-run clinics, seven of which closed in April.

### ***Physicians took greatest hit***

AN ARTICLE APPEARING IN THE *DAILY Southtown* reported that doctors and nurses make up 47 percent of the known cuts at the Cook County health bureau. According to information obtained, the final budget eliminated 260 doctors and residents and 230 nurses and certified nursing assistants. The cuts don't include physicians and nurses working in administrative posts.



### **What is PHIRE?**

Public Health Information Rapid Exchange (PHIRE) is an electronic communication system designed to keep healthcare providers informed and in position to preserve and protect our nation's health. Through PHIRE, registrants receive real-time, accurate health information during emergencies such as in the event of an outbreak of pandemic influenza. Clinicians will also have access to scheduled moderated forums to ask questions.

### **Registration**

Registration is simple and only takes a few minutes. A full description of the system, its rationale and frequently asked questions (FAQs) can be found when you visit [www.cdc.gov/phire](http://www.cdc.gov/phire). To register on the PHIRE system, follow the link provided in your initial invitation, and complete the following steps:

1. Agree to terms of use
2. Enter email address and create password
3. Describe your work setting
4. Select categories of interest

### **Targeted Alerts**

The information you provide (e.g., your primary work setting and your county) will enable the CDC to target relevant emergency health information specifically to your needs. For example, should evidence of

unusual numbers of influenza cases occur in your area, the PHIRE system would notify you, and offer guidance on what to do or where to go for more information. Topics include:

- Terrorism
- Natural / Man-made events
- Infectious disease
- Vaccine-preventable diseases
- Environmental health
- Chronic disease

### **Security**

Participation in PHIRE is by invitation only. At this time, we ask you not to forward this information to other colleagues as the CDC is engaging in a stepwise process for registering clinicians, hospitals, laboratories, and other partners. The system and its content will be managed by a CDC expert who will exercise great discretion for the quantity and quality of information provided to you and will take all necessary precautions to keep your information confidential.

### **Cost and Control**

There is no charge for becoming a part of this important network, and most importantly your e-mail address will not be shared. Registration only takes a few minutes and, since PHIRE uses a self-registration process, you can manage your level of participation or discontinue if you elect to do so.
