LEGISLATIVE ALERT

Trial lawyers' bill goes to governor

CMS, ALONG WITH ISMS, IS STRONGLY urging the governor to veto HB 1798. This legislation is clearly a disguised "grab for cash" by the plaintiff lawyers.

The proposal would create a new way for plaintiffs to receive compensation in wrongful death cases.

Current law already provides for proper recovery in wrongful death cases. Today, the spouse and next of kin may recover for loss of society and compa-

nionship with the deceased. Such damages include deprivation of love, care, comfort, protection, guidance, advice and affection of the deceased. Substantial sums are already awarded in cases for these losses.

The bill was approved 31-23 along party lines in the Senate and passed the House 63-52. As of press time, Governor Blagojevich had yet to decide if he'll sign the bill.

FRONTLINE PERIL

CMS opposes Stroger cuts

Your leadership wrote last February to County Board President Todd Stroger, urging "great care" in carrying out budget and staff cuts within the Bureau of Health Services. "Frontline physicians are highly trained professionals who constitute the core of Cook County's public medical care infrastructure. They must not be sacrificed *en masse* to bean counters and bureaucracy—action that would further imperil an already fragile county system. We expect Cook County leaders and budget cutters to follow state law, regulation, and the institution's own medical staff bylaws in any restructuring that might occur," wrote President Shastri Swaminathan, MD.

Young docs added to Council

YOUNG PHYSICIANS--THE PROFESSION'S future—are gaining a new voice on the CMS Council. Effective this summer, each District will be allowed to add young physicians as councilors and as alternates to represent young members of their respective dis-

"MEDICAL HOME MODEL"

Update: *Illinois Health Connect*, a new HFS program

THE ILLINOIS DEPARTMENT OF HEALTHCARE and Family Services (formerly the Illinois Department of Public Aid) has moved to a Primary Care Case Management (PCCM) model for most medical program (Medicaid and *All Kids*) clients. This model of health care delivery is also known as the "medical home model" and has been shown to enhance primary and preventive care services. Twenty-nine other states have adopted similar programs for their clients and have shown a gradual decrease in ED usage, an increase in primary care and preventive services (such as immunizations) for patients, and decreased costs. In Illinois, this program has been named *Illinois Health Connect* and is being administered by Automated Health Systems (AHS).

Overall, 1.6 million patients including 1,100,000

children enrolled in *All Kids*, 370,000 adults enrolled in *FamilyCare* and 110,000 elderly or disabled adults are eligible for *Illinois Health Connect* and will choose one Primary Care Provider (PCP) to act as their "medical home." **Physicians willing to provide a medical home for patients must enroll as an Illinois Health Connect PCP.** They can specify how many patients they want in their panel from 1 to 1,800 and limit the panel based on existing patients, age limits, or gender. PCPs will receive a monthly management fee in addition to the fee-for-service reimbursements for each visit. Primary care physicians who do not enroll will no longer be able to provide primary care to their HFS patients enrolled in *Illinois Health Connect* without a referral.

PCPs will provide referrals for patients to see specialists. Referrals are registered with AHS and shared with HFS so claims by specialists will be paid. Referrals are NOT reviewed for medical ne-

The Parliamentary Procedures course is intended to help physicians become active in their societies. 6. List five rules governing debate
7. Identify five essential points to successfully preside over a meeting
8. Utilize the ranking motions

What's New with the 2007 OSHA Training Workshops?

OSHA requires annual training for **all** health care workers with potential occupational exposure to blood-borne pathogens. Attend the two-hour training course, update your exposure control plan and satisfy most of your yearly OSHA regulations.



All seminars are taught by specialists in exposure control. The course is designed for clinicians and their staff, including **dentists** and **dental medical staff**. At the conclusion of this activity, participants should be able to: 1) Identify the requirements of OSHA standards including blood-borne pathogens; 2) Explain how the standards apply to them; 3) Discuss and select safer needle devices; and 4) Identify safety and health hazards at their facility.

OSHA requires that all health care employers maintain a written **Exposure Control Plan**. The plan must include a risk analysis, Hepatitis B vaccinations, follow-up procedures, an evaluation of safer sharps and training. The two-hour update will provide you with tools, including a sample program, to ensure that you meet all the requirements. OSHA requires that your plan be reviewed annually, that the newest technology be reviewed annually, and that training is repeated annually.

Also, have you ever attended a workshop only to realize that after the workshop's completion you still had questions that were unanswered? As a result, the Chicago Medical Society and the Chicago North office of OSHA have obtained a list of **Frequently Asked Questions** from former OSHA attendees. cessity or “pre-authorized.” Patients will NOT require a referral to receive care in the ED or for in-patient care. Labs, diagnostic studies, PT/OT/ST will NOT require referrals.

Specialists do not need to enroll but will need to verify that a referral has been registered by the PCP before submitting a claim for services. AHS is also developing a specialty database that will assist PCPs in identifying specialty providers who are willing to care for their patients enrolled in *Illinois Health Connect*. Specialists who would like to be included in the database can contact AHS at 1(877) 912-1999.

Until the referral system is implemented, claims will continue to be processed without a referral. Providers will be notified by AHS prior to full implementation of the referral process. It is anticipated that the referral system will be available in late 2007.

Cook County Status

Approximately 850,000 *Illinois Health Connect* HFS clients living in Cook County must pick a medical home. Beginning on Feb. 16, 2007, and proceeding through March, AHS sent initial enrollment materials to these clients. (You can review the enrollment materials that were sent to clients on the *Illinois Health Connect* web site at <http://www.illinoishealthconnect.com/clientmaterials.aspx>). HFS clients who live in Cook County have the option of enrolling in a medical home through *Illinois Health Connect* or the managed care organizations, Harmony Health Plan or Family Health Network. The original time frame for enrollment allowed clients 60 days from the receipt of their initial materials to actively select a PCP. At the end of the 60-day period, any client who had not selected a medical home would be “auto-as-

signed” to a PCP. A small percentage of patients in Cook County were auto-assigned according to the 60-day schedule; however, it became apparent that in order to accommodate the large volume of client phone calls and allow every client a reasonable opportunity to choose a PCP, the 60-day time frame should be extended and auto-assignment was delayed. (Auto-assignment has proceeded according to the schedule in the collar counties.) Currently, approximately 450,000 patients in Cook County have chosen a medical home and been enrolled in either an MCO plan or *Illinois Health Connect*. For the remaining approximately 400,000 patients, auto-assignment is anticipated to resume by the end of May, and patients will be receiving their second enrollment packets soon, informing them that they need to select a medical home or they will be auto-assigned.



Q & A

Q. What is the ISMS and CMS Recruiter Rewards Program?

A. The Recruiter Rewards Program allows ISMS and CMS members to receive rebates on their membership dues through the direct recruitment of other physicians as members.

Q. How many members do I need to recruit and how much is the rebate?

2 New Members	15% Dues Rebate
3 New Members	30% Dues Rebate
4 New Members	50% Dues Rebate
5 New Members	75% Dues Rebate
6 or More New Members	100% Dues Rebate

Note: Student and resident recruiters will be given gift certificates in lieu of rebates.

Q. Who is eligible?

A. Those eligible as recruiters are individual physicians, groups with nine or fewer physicians, and groups of 10 or more physicians that do not participate in the Group Dues Program. ISMS and CMS officers and trustees are not eligible for this program.

Q. Who qualifies as a new member?

A. For the recruiting member to receive the “dues discount credit” for a new member, all newly recruited physicians must:

- 1) Be dues-paying members; recruitment for a non-dues paying membership category is not counted towards a recruiter dues discount credit.
- 2) Be a first-time member or a reinstated member whose membership was not active for one full year.
- 3) Include the recruiting member’s name on their membership application.

Note: Physicians recruited after June 1 who pay half-year dues will not initially count towards their recruiter's discount until they pay their full-year membership dues the following year. Once this payment is made, the discount for the recruiter will be applied towards the following membership year.

Q. Can I opt out of my rebate?

A. Yes, ISMS and CMS member recruiters may waive their allotted discount if they so desire, in favor of an equal amount contribution made in their name to the Illinois State Medical Society Political Action Committee (IMPAC).

CMS COUNCIL HIGHLIGHTS

May 8 meeting spotlights Midwest Clinical Conference, single payor system, and Patient Simulation Center

- CMS Leadership announced the departure of Executive Director James Tarrant; and the Council rose to thank Mr. Tarrant for nine years of service. During his tenure, Mr. Tarrant made it possible for CMS to be part of major health care discussions in the Chicago area, said CMS President, Dr. Shastri Swaminathan. A search committee for a new

executive director has been formed; chaired by Immediate Past President Steven M. Malkin, MD, the committee is comprised of Executive Committee and at-large members. Mr. Ted Kanellakes, director of member services, will serve as interim executive director.

- The Council recognized members of the ISMS Fifty Year Club. Among CMS members honored were Drs. George S. Farah, Zahirul Huq, M. Barry Kirschenbaum, Manus C. Kraff, Arthur R. Peterson, Hernan M. Reyes, Jafar Shah-Mirany, and Malachi J. Flanagan.

- Responding to the national political debate on health system reform, CMS is reactivating its committee on a single-payor system. Members are encouraged to serve. For more information, contact Ted Kanellakes at (312) 670-2550.

- This year, according to Dr. Swaminathan, the Membership Department has turned the battleship around, adding 330 members. Dr. Swaminathan stressed the importance of maintaining, as well as recruiting, new members. He said, "Our job, as counselors and delegates, is to encourage membership. We must find out what new members are interested in, match their interests, and keep them engaged throughout their careers." CMS/ISMS membership data show that 50% of new members drop out of the organization within five years.

- CMS resolutions were debated at the ISMS House of Delegates in April; the majority of them were adopted. The Third District had a healthy attendance. Next year's meeting will be held April 10-13 in Oak Brook.

- CMS went on record supporting the position of infectious disease societies in opposing MRSA leg-

isolation in Springfield. Leaders fear it would have negative consequences for physicians, hospitals and patients. The bill would require that all hospitalized patients be screened for the presence of MRSA and reported to IDPH if positive.

- The consolidated audit of CMS, the Insurance Agency, Service Bureau and Foundation shows a \$138,000 loss for 2006, far less than anticipated. The four components are being managed successfully, said CMS president-elect Saroja Bharati, MD.

- The Midwest Clinical Conference 2008 will be held in conjunction with another organization or a hospital to be determined; the CMS Foundation's mission continues to be educating doctors.

- The CMS Regional Patient Simulation Center held an Open House on May 30 at Society Headquarters. This was an opportunity to see the potential of simulation as a tool in CME programs, risk management and skills training. Tours were conducted by John Schneider, MD, and outgoing CMS Executive Director James Tarrant.

- Eight members were recognized for volunteer service on the CMS Council. They are: Drs. Amalendu Majumdar, Raghu R. Vollala, Harish Bhatia, Sharad K. Khandelwal, Jose L. Medina, Fritz R. Michel, Bohdan A. Iwanetz, and Peter B. Segal.

- The Council adopted policy expressing support for adequate registered nurse staffing in hospitals. The language further calls for creating an IDPH taskforce with active physician participation to evaluate nurse staffing at Illinois hospitals, set staffing levels, and recommend methods to assure compliance.

NEWS FROM ISMS

Thumbs down to gross receipts tax

Following is an update of initiatives and issues on members' behalf.

● ISMS House says "No" to GRT!

ISMS members attending the annual meeting in April rejected Governor Blagojevich's proposal to fund health insurance expansion through a gross receipts tax. A tax on medical services would take dollars from one pocket to put them in another, leaving physicians with no means to pass along the costs, the HOD decided. Fortunately, the Illinois House of Representatives also agreed that the idea was unsound, and gave it a "thumbs down" vote of 107-0.

● Delegates affirm support for universal patient access

In denouncing "one-size-fits-all" state-stipulated insurance coverage, the ISMS HOD affirmed that

patients should be able to choose from several private and public health insurance options. Shortly after the meeting, the Society released its recommendations in ISMS' *Principles for Health System Reform*.

● Society speaks out on retail health clinics

ISMS hopes to get legislation passed this spring that would more closely monitor hundreds of in-store clinics being opened by retail stores. The Society's legislative efforts figured prominently in a recent *Chicago Tribune* business section. HB 1885, the "Retail Health Care Facility Permit Act," calls for regulation by the Illinois Department of Public Health, for each in-store clinic to apply for a permit, for the regulation of marketing, and for increased supervision of clinical nurse practitioners, quality of care and follow-up. CMS leadership met with Walgreens to discuss in-store clinics.
