This program will give participants a medical-legal overview of changes in the health care delivery systems, their impact on the practice of medicine, and various strategies to meet these challenges.

Physician Workforce and Shortage Issues -Looming Crisis: Health Care Reform in Illinois: Role of Allied Health Professionals

While the Affordable Care Act has paved the way for states to expand coverage for more Americans, we are facing a growing shortage of physicians nationally. This is especially challenging in Illinois, which has expanded Medicaid coverage for over 250,000 residents. Illinois like other states has a shortage of doctors in primary care and certain specialty services. Allied health professionals will have to provide some of the services while medical schools and training institutions find a way to train more doctors in graduate medical education. A View From The Cloud. Cutting-Edge Insight on the HIPAA Omnibus Rule, Cloud Privacy & Security, and HIPAA Enforcement

With this backdrop, health care providers have had to deal with: (i) a newly released HIPAA Omnibus Rule, which was the first major HIPAA update in years; (ii) newly robust enforcement of HIPAA and information privacy/security laws from both the state and federal government; (iii) heavy fines and risks from enforcement efforts; (iv) scrutiny from privacy advocates; and (v) the

ever-present HITECH Act and Meaningful Use, with their not-so gentle-nudges into the digital age.

What's an honest health care provider to do? This session will provide expert guidance on the HIPAA Omnibus Rule, Cloud Privacy & Security, and the inner workings and thoughts of a federal government HIPAA enforcement expert, on these and other related topics.
