

**Description:**

On the heels of the #MeToo movement, Illinois has taken action by requiring employers to identify, prevent, and remedy sexual harassment in the workplace. Effective January 1, 2020, all Illinois employers must provide annual sexual harassment training for all employees working in the state. This 1-hour training will provide you with an overview of sexual harassment in the workplace – what it is, what it isn't, how to promote a work culture of non-harassment, a review of the laws governing appropriate and professional conduct in the workplace, and how to investigate and deal with hostile work environment complaints.
