**Overview:** *Based on the fact that you can increase your catchment area to anyplace in the country (or world) with a high-speed internet connection and the right software, there are various implications regarding state medical licensure. Physicians can’t really practice across state lines without a license. There is a movement to have a single license in the U.S., allowing physicians to practice in any state.*

*There is also the issue of billing. Several states have passed legislation regarding parity of compensation when billing is submitted for telehealth visits; however, most states have not yet passed such legislation. This CME activity will address the current implications with state medical licensure, legislative and billing and practicing telemedicine.*
