In an upcoming interview for *Chicago Medicine*, Dr. Wilhelm, a CMS member, says he looks forward to meeting with CMS lead-

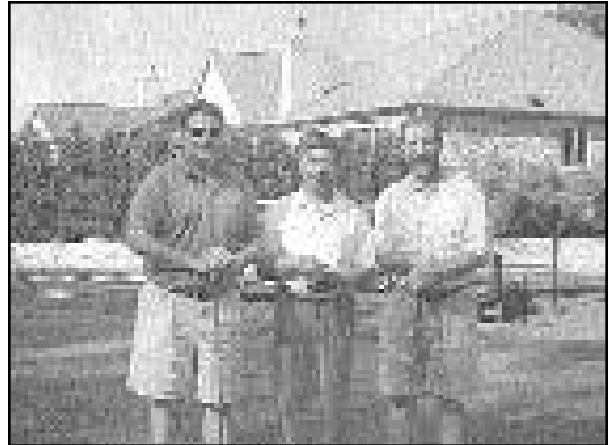

CONVERGING IN CHICAGO

Highlights from the AMA annual meeting



Olson

MORE THAN 1,000 DELEGATES and alternate delegates from around the country converged in Chicago for the 100th anniversary of the AMA House of Delegates June 17-21.

At the local level, the Society was well represented with Sandra F. Olson, MD, winning a seat on the AMA's Council on Medical Education. Dr. Olson is a past president of both CMS and ISMS. The national leadership also considered four resolutions originating at CMS: Reimbursement for physician services; deduction of interest on student loans; malpractice information on the Internet; and health system advertising.

New U.S. Secretary of Health and Human Services Tommy Thompson outlined changes at HHS

including the recent renaming of the Health Care Financing Administration to Centers for Medicare and Medicaid Services.

Outgoing AMA President Randolph D. Smoak, Jr., MD, issued a challenge to the nation's physicians to dedicate some part of their career to caring for the sick in parts of the world ravaged by AIDS and other diseases. Incoming President Richard F. Corlin, MD, said he will dedicate his presidency to securing funding to research the epidemiological causes of gun violence. He wants Congress to restore funding to the Centers for Disease Control and Prevention to track gun-related homicides, suicides and injuries.

Controversy also played a role at the AMA meeting with the filing of a lawsuit by Executive Vice-President E. Ratcliffe Anderson, Jr., MD. For an overview, read the President's Perspective in the August issue of *Chicago Medicine*.

Hepatitis A vaccine available through the Chicago Vaccines for Children (VFC) Program

THE CHICAGO DEPARTMENT OF PUBLIC Health (CDPH) has hepatitis A vaccine available for children two to 18 years of age through the Vaccines for Children (VFC) program. Physicians who are enrolled in the VFC program can receive hepatitis A vaccine at no charge through the program.

Children play an important role in hepatitis A transmission. Children attending day care or persons working in day-care centers may account for as much as 11 to 16 percent of cases reported to the Centers for Disease Control. Approximately half of all persons with hepatitis A have no identified source of their infection. Children are usually asymptomatic and therefore can serve as an unrecognized source of infection.

The Centers for Disease Control (CDC) recently expanded the availability of hepatitis A vaccine to include persons in states, counties and areas where the average annual hepatitis A rate was at least 10 cases/100,000 population. Chicago has an average case rate of 12.2 cases/100,000 population.

ADVISORY COMMITTEE ON IMMUNIZATION PRACTICES (ACIP) CASE RATE DEFINITIONS

High	≥ 20 cases per 100,000 population
Intermediate	□ 10 cases per 100,000 population and < 20 cases per 100,000
Low	< 10 cases per 100,000 population

Recommendations from the Advisory Committee on Immunization Practices (ACIP) include routine vaccination of children two years of age and older in areas with high rates of hepatitis A disease. Children living in areas with intermediate rates of hepatitis A disease should be *considered* for routine vaccination.

Physicians who are not currently enrolled in the VFC program or who have questions about enrolling can call CDPH at (312) 746-6358.
