"LOW-BALLING" TACTICS IN THE MALPRACTICE insurance industry have resulted in dangerously low reserves and painfully steep prices.

These were the conclusions of an article published last summer in *Medical Economics* that attributed most of the blame to certain "bargain" insurance companies that have held premium rates artificially low for years to gain market advantage.

But, fortunately, some companies have continued to provide Cook County and greater Illinois physicians with a sound product at a reasonable price, despite market pressure to do otherwise.

The Illinois State Medical Inter-Insurance Exchange is one such company, and is endorsed by CMS.

ISMIE maintains its ongoing viability through a consistent approach to policy rating; its steadfastness ensures that it can meet its responsibilities to policyholders.

We hear you: CMS membership survey results are in

OVER THE SUMMER, CMS MAILED more than 7,000 surveys to the entire membership asking for members' opinions on how well we serve you. More than 900 physicians responded. Here are the results: • Members value the education and advocacy CMS conducts on their behalf. These activities are considered the main benefits of membership. The relationships that CMS is building with such organizations as the Civic Coalition, Chicago Public Schools, Chicago Department of Public Health, and the Chicago Bar Association are highly regarded by members—they recommend that we continue to pursue these relationships.

• About half of all respondents listed ISMIE insurance as their professional liability insurer. (For those members who are not aware of CMS' expanding relationship with ISMIE—we have endorsed the insurer in exchange for a royalty that will allow additional CMS services. As part of that agreement, CMS has hired a Physician Practice Advocate to work closely with members. See page 5 for more details.)

• Fifty-seven percent of respondents said they prefer not to receive information by e-mail.

Patients' rights conference committee underway

Senate bill is best plan for Americans

OVER THE COMING MONTHS CONGRESS will face the challenge of negotiating the differences between the House and Senate versions of the patients' bill of rights. The AMA and ISMS strongly support the bill passed by the Senate and adamantly oppose the House bill containing an amendment championed by Rep. Charles Norwood (R-Ga).

The AMA has prepared detailed comparisons of the legislation that make clear why the Senatepassed bill is far superior. Furthermore, the AMA is working hard to ensure that Congress, physicians and patients know just what those differences are. The Senate bill:

• Protects existing state accountability and external medical review laws.

• Enables patients to hold their HMO accountable in state court when the health plan makes medical decisions that cause injury or death.

• Ensures that patients and health plans are on equal ground during a court review of an HMO's medical decision.

• Preserves emerging case law protecting patients.

• Protects physicians and other health-care professionals from new liability in state and federal courts.

The two bills are the same with regard to provisions for access to emergency services, specialists, obstetrician-gynecologists, and pediatric care. Both would guarantee continuity of care, the point of service option and both would ban physician-patient gag clauses.

In the AMA's analysis of differences between the two bills (see chart on page at right), the Norwood amendment preempts state liability and external review laws, contains severability clauses that could invalidate all patient remedies in the bill, prohibits RICO class action lawsuits and exposes physicians to new liability in state and federal courts.

Demonstration project seeks physician volunteers

Program to pilot test measurement tools

PHYSICIANS CAN MAINTAIN CLINICAL excellence through the Physician Consortium for Performance Improvement (the Consortium), a physician-led initiative convened by the AMA.

The Consortium aims to provide evidencebased clinical performance measures and outcomes reporting tools to practicing physicians.

The Consortium is currently working with volunteer physicians to pilot test measurement tools for adult diabetes, chronic stable coronary artery disease, and prenatal testing.

Performance measures are not clinical guidelines; rather, they are *derived* from evidence-based clinical guidelines and indicate whether or how often a process of care or outcome of care occurs (e.g., how many and which patients with diabetes
