## LANDMARK CMS RALLY IN DALEY PLAZA

### **Access to care is key point**

ILLINOIS' ERODING HEALTH-CARE SYSTEM is leaving physicians, nurses and patients with unhealthy options. That's why CMS brought together physicians, their staff and patients at a landmark rally on May 13. The rally, held at the Daley Plaza, aimed to increase awareness about the increasingly difficult medical practice environment and its negative impact on access to care.

Physicians wore their white coats to send an important message to the state's legislature: Medical liability reform is not about the cost of being a physician, it is about the cost of being a patient. AMA Vice-chair William G. Plested III, MD, ISMS President William E. Kobler, MD, and CMS President Richard A. Geline, MD, were featured speakers at what was one of the largest medical liability reform rallies in the United States to date. We hope you were there so you could be counted.

### **Physicians and patients— Contact Senator Durbin now**

*Urge him to support S. 607*

**What is S. 607?** A bill introduced by Sen. John Ensign (R-NV) that would improve patient access to health-care services. S. 607 is the Senate version of H.R. 5, the HEALTH Act, which passed the U.S. House last March. The bill would reduce the excessive burden the liability system places on the health-care

delivery system. And like H.R. 5, this legislation is modeled after California's MICRA law, which has stabilized the malpractice liability system in that state since 1975.

Your support is necessary to help secure the additional votes needed in the U.S. Senate to pass federal MICRA-style reforms.



## FOCUS ON SMALLPOX

### ***Bioterrorism preparedness program: Will you be ready?***

IF A PATIENT WALKED INTO YOUR OFFICE with smallpox, would you recognize the symptoms? Would you know how to respond? CMS' free, one-hour CME course, "Bioterrorism Preparedness Training for Physicians: A Focus on Smallpox," continues this month with dates scheduled on May 21 and 28 (see page 7 for registration form). The program, which began in February, is open to *all health-care professionals* in Cook County, including doctors, nurses, nurse practitioners, residents, and any others who may come into contact with patients.

A course held last month at Advocate Bethany Hospital received a ringing endorsement from Clement S. Rose, MD, president of the medical staff

at Bethany. "On behalf of the medical staff, I would sincerely like to thank...the Chicago Medical Society for the extremely timely and very much needed CME presentation on bioterrorism preparedness," wrote Dr. Rose in a letter to CMS. ## MEDICAL MALPRACTICE INSURANCE

### **ISMIE Mutual announces 35.2 percent base rate hike**

*Cites state's deteriorating civil justice climate as cause*

ISMIE MUTUAL INSURANCE COMPANY, THE state's largest writer of medical liability insurance coverage for physicians, has announced an annual base rate increase of 35.2 percent for its 14,000-plus policyholders, effective with the July 1, 2003, policy year. Letters to policyholders detailing the increase went out the week of April 28.

"We realize the enormous burden this poses for policyholders and their patients, and we deeply regret that the deteriorating civil justice climate left us little choice but to act," stated Harold L. Jensen, MD, ISMIE Mutual chairman. "The physicians on ISMIE's Board looked at every possible way to minimize this increase. However, in the last two years, the company's average payout per claim climbed 59 percent to \$612,000. The number of reported cases jumped 36 percent over the last nine months alone. We cannot sustain those loss trends without raising premiums substantially."

In addition to the base rate increase, the market environment is forcing ISMIE to significantly reduce existing discounts afforded policyholders. This means some physicians will experience premium hikes well in excess of 35 percent. The company has already imposed a moratorium on new business, which took effect Jan. 1, 2003. In 2002, ISMIE had taken in approximately 2000 new policyholders as several commercial carriers exited the Illinois market. "We want to serve Illinois physicians, but we have topped out on our financial resources available to write new business," explained Dr. Jensen.

"The cost driver in medical liability is non-economic damage awards," continued Dr. Jensen. "What's needed is a proven solution, a reform law similar to that adopted in California some years ago. It protects patients by giving them full and unlimited compensation for all their economic losses due to injury through medical negligence. At the same time, it caps at \$250,000 the unpredictable category of non-economic damage awards such as for pain and suffering."

ISMIE Mutual is urging physicians and patients statewide to call on Congress to enact a \$250,000 cap on non-economic damage awards, as embodied in H.R. 5 and S. 607.

## **Highlights from ISMS House of Delegates meeting**

*AMA: Illinois joins growing list of states where patient care is in crisis*

AMID STORIES OF ILLINOIS PHYSICIANS forced to retire early, relocate, or abandon their practices, ISMS held its annual House of Delegates meeting in April. Many resolutions—some with titles like “Cap on Malpractice Awards,” “Help with Tort Reform,” “Malpractice Abuse: Time to Take the Trial Lawyers to Court,” and “Tort Reform Legislation in Illinois”—reflected the fighting mood across the state and within specialties.

Spearheading the campaign for change was guest speaker J. Edward Hill, MD, chairman of the AMA Board of Trustees. Dr. Hill described vigorous lobbying efforts for tort reform by the AMA in Washington, DC. Standing squarely behind H.R. 5, the HEALTH Act, and S. 607, the Senate version of H.R.5, the AMA has made national liability reform its highest priority.

While the medical liability morass figured prominently in shaping this year’s policy agenda, the HOD also considered numerous other resolutions. Fourteen of those were submitted through CMS; nine were adopted, two were not adopted, and three were referred to the ISMS BOT. For complete coverage of the resolutions, watch for the spring issue of *Chicago Medicine*.

*(Following the lead of other local medical societies, the Cook County delegation, led by CMS President Richard A. Geline, MD, held its own medical liability reform rally on Chicago’s Daley Plaza on May 13. The CMS rally, which was supported by ISMS, AMA and the Chicago Metropolitan Healthcare Council, was the largest in Illinois and possibly even in the country. Physicians called for improved access to care for patients and caps on non-economic damages, based on proven reforms working in California.)*

Among the new ISMS officers elected were William E. Kobler, MD (Rockford), president, Kenneth J. Printen MD (Evanston), president-elect, and Ronald L. Ruecker, MD (Decatur), chairman of the Board of Trustees.

#### *Highlights from the 59th Annual Midwest Clinical Conference at Navy Pier, March 20-22*

A NEW CLASS BASED ON THE GAME SHOW *Jeopardy* offered physicians an entertaining change from traditional slide presentations. In "Trauma Jeopardy—Emergency Room Care," audience members participated as contestants, while a panel of experts asked questions focusing on pediatric and geriatric trauma. The brainchild of course director and moderator Thomas Vargish, MD, the format emphasized common problems and pitfalls of managing injured patients.

Another program highlight was "Trigger Point and Joint Injection Techniques," led by Edward Abraham, MD, professor and chairman of the Department of Orthopedics at the University of Illinois. The course made use of human cadavers to help physicians become more comfortable giving injections in their clinical practices, avoid complications associated with injection procedures, and identify anatomical landmarks and structures necessary for successful injections.

Other popular MCC courses included:

- "Conscious Sedation: Adults & Children"
- Physicians were also eager to learn about the new HIPAA security rule and how to bring their offices into compliance with the law. "HIPAA: Will You Be Ready on April 14," cosponsored by the CMS and AMA, had standing room only.
- "Bioterrorism Preparedness Training for Physicians: A Focus on Smallpox" filled Navy Pier's Grand Ballroom.

Highlights from the MCC Annual Public Service Award luncheon were:

- Keynote address by Illinois Senator Peter G. Fitzgerald in Washington, D.C., giving a candid talk via conference call on where physicians stand today legislatively.
- Speech by Edward Murnane, president of the Illinois Civil Justice League, who focused on the need for a fair and impartial judiciary and the importance of contacting senators and representatives.
- The 2003 Henrietta Herbolzheimer, MD, Public Service Award, honoring John R. Lumpkin, MD, MPH, former director of the Illinois Department of Public Health (1991-2003).

## ***Plight of uninsured examined***

CMS PHYSICIANS WERE AMONG THE thousands of Chicago-area individuals and more than 85 organizations participating at the local level in "Cover the Uninsured Week," a series of nationwide events focusing on the plight of the nation's 41 million uninsured.

Held the week of March 10-16, activities consisted of town hall meetings, on-campus school-wide teaching events, free health screenings, and inter-faith events. Former presidents Gerald Ford and Jimmy Carter served as honorary co-chairs.

CMS President Richard A. Geline, MD, and President-elect Neil E. Winston, MD, represented CMS at a town hall meeting complete with panel discussion and press conference. Elected officials signed a proclamation, pledging to help alleviate the problem of the uninsured. An uninsured family spoke about the challenges its members face without health-care coverage.

CTUW was cosponsored by the American Medical Association, American Hospital Association, Federation of American Hospitals, Catholic Health Association of the United States, United Way of America, Blue Cross and Blue Shield Association, Robert Wood Johnson Foundation, American Nurses Association, U.S. Chamber of Commerce, AFL-CIO, the Business Roundtable, Service Employees International Union, Healthcare Leadership Council, and AARP.

## **Predicted Medicare payment cuts prove formula is flawed**

THANKS TO QUICK CONGRESSIONAL ACTION to correct the 2003 Medicare payment crisis, physicians will see a 1.6 percent increase in reimbursement this year instead of a 4.4 percent cut. This gain translates into \$54 billion for physician payments over ten years.

**However, due to fundamental flaws in the formula for determining the physician reimbursement rate, the Centers for Medicare and Medicaid Services (CMS) is now predicting a 4.2 percent cut for 2004.**

This new projected cut is not the result of a deliberate decision by Congress. It is the unintended consequence of an unsound and unworkable Sus-

tainable Growth Rate (SGR) formula. The SGR cuts payments if growth in Medicare patients' use of services exceeds GDP growth. At the same time, however, the government induces greater use of physician services through new coverage decisions, quality improvement initiatives and a host of other quasi-regulatory decisions that are good for patients but not reflected in the SGR. The Medicare Payment Advisory Committee (MedPAC) established by Congress recommends replacing the SGR with an update process similar to the approach used for Medicare hospital updates. For 2004, MedPAC has recommended an increase of 2.5 percent instead of the projected 4.2 percent cut.

***Call your representatives and senators today --*** Urge your elected officials to implement the MedPAC recommendations to replace the SGR with a more equitable update process for Medicare physician payment and to increase 2004 payments by 2.5 percent.

## **Supreme Court tells HMOs to open their networks**

IN A MAJOR RULING THAT GIVES PATIENTS greater choice in selecting doctors and states more power to regulate the managed care industry, the Supreme Court ruled unanimously that HMOs can be forced to open their networks to more health-care providers.

“For the second time in 12 months, justices have asserted that managed care organizations cannot escape compliance with state laws regulating insurance,” said AMA President-elect Donald J. Palmisano, MD. “The AMA has repeatedly maintained that health insurance companies cannot avoid accountability to state laws regulating insurance by hiding behind ERISA.”

The AMA Litigation Center, together with the Kentucky Medical Association, American Psychiatric Association, National Medical Association and American College of Obstetricians and Gynecologists filed an *amicus curare* brief in *Kentucky Association of Health Plans v. Miller*.
