MESSAGE FROM YOUR PRESIDENT

CMS forms council to work with hospital medical staffs

You will soon be hearing more about a new Council being developed and implemented by the Chicago Medical Society, focusing primarily on hospital physicians and university hospitals. The Illinois State Medical Society (ISMS) is working closely with CMS on programming in support of this initiative.

The Council's primary goal is to show hospital medical staff leaders what organized medicine does and to let them experience the services and resources available to members. By serving as a resource to the leadership, the Council will build a network of individuals CMS/ISMS can work through to communicate with members and non-members alike. And indirectly, the Council will become a resource to CMS/ISMS, complementing retention/recruitment efforts, and demonstrating the benefits of membership.

The benefits/services include:

- Quarterly Meetings—These will provide networking opportunities for medical staff leaders, facilitate conversation on issues affecting them, and assist with developing educational programs structured to their needs and interests. The first meeting will be held in the next few months; guest speaker will be Rob Kane, JD, ISMS legal services. Mr. Kane

will discuss issues affecting hospital medical staff by-laws.

- Quarterly Newsletters—These will provide information specific to hospital medical staff issues in Illinois. The content will include information on medical/legal issues, legislation, and legislative/judicial elections.

- Research—CMS and ISMS will research issues and provide talking points based on the interests and needs of hospital medical staff leadership. Staff will also provide information on CMS/ISMS initiatives.

Planning summit takes on issue of membership

TACKLING THE MEMBERSHIP CRISIS HEAD-ON, CMS President Saroja Bharati, MD, convened a planning summit on Oct. 27 to determine how CMS can reach out and retain new members, particularly women, residents, students and ethnic groups. Nearly 30 leaders participated in the Saturday morning roundtable, which included representatives from every district and committee, as well as the CMS Board of Trustees.

CMS has a greater role to play than ever, and rebuilding the Society will require the work of

many, said Dr. Bharati. She challenged leaders to help her in recreating the Society for a new millennium, building upon CMS' historic mission.

Among the many suggestions at the meeting:

- Increase CMS' visibility in the County and City.
- Better represent the needs of employed physicians, paying greater attention to the younger generation, the lifeblood of organized medicine.
- Survey students and residents about their professional and personal concerns.
- Offer mentorship opportunities, job assistance, guidance on negotiating contracts and on insurance to young doctors.
- Focus on the increasingly female workforce and dual doctor families; 50 percent of medical students are now women; they will have childcare issues, need health insurance, and will seek their own professional forums.
- Streamline electronic publications. As of November, the monthly *Chicago Medicine* newsletter will be sent electronically. CMS will continue to print a few paper copies for those without email who request a copy.
- Improve the Web site so users can apply online for membership, take online CME courses, and register for CMS events.
- Address the core values of the medical profession.
- Approach hospital administrators and large group practice managers to better understand the issues and needs of employed doctors.
- Target specific groups, offering discounts to medical staffs or to groups based on size.
- Promote lobbying and advocacy efforts.



“Students should be integrated into membership, they shouldn’t be a separate district,” suggested Hans Arora, co-chair, CMS Student District.

- Offer access to legal opinions or help on dealing with insurance companies.
- Look at what specialty societies have to offer and work at filling the gap.
- Advocate for patients and work with community coalitions.
- Host political candidates, offer online forums; allow non-physicians to join CMS as associates or “friends of the Society.”
- Identify hospital liaisons; if leaders cannot personally serve as liaisons, they should identify potential candidates to assist in membership recruitment.
- Recruit medical staff section chiefs, the key players who can influence colleagues and residents.
- Redefine and expand the CMS mission statement.
- Promote affinity partners; offer health and auto insurance, legal and financial services.
- Improve and expand CME and offer assistance with coding issues.
- Establish a “swat team” of practice consultants to evaluate practices.
- Identify key leaders to represent CMS at health care and legislative forums.

The discussion returned frequently to the issue of value. While everyone attending the meeting would agree membership is well worth the cost, many felt that most of the medical community is unaware of the good that organized medicine is

doing on their behalf, or are simply taking it for granted.

Following a brief question-and-answer period, Dr. Bharati encouraged members to continue the conversation by sending in their ideas. She thanked everyone and called the summit, “a beginning, not an end.”

CMS pilot program to encourage healthy lifestyles

HELPING CHILDREN MAKE HEALTHIER food choices has long been a passion for CMS President Saroja Bharati, MD. Meeting with Chicago Public Schools CEO Arne Duncan at CPS headquarters recently, she proposed a curriculum that would teach healthy lifestyle habits to grade school students. Her program would bring CMS physicians into the schools to educate, engage and encourage kids. But students wouldn't be the only ones—doctors would reach out to teachers and parents as well. Dr. Bharati's plan also calls for collaboration with the American Heart Association and American Medical Association.

Mr. Duncan welcomed Dr. Bharati's suggestions and encouraged CMS to develop a pilot program.

Dr. Bharati: Residents key to future

CMS PRESIDENT SAROJA BHARATI, MD, AN educator in cardiac pathology, spoke recently to residents at Illinois Masonic Medical Center. But

her lecture wasn't on the science of heart disease; she came instead to encourage doctors in training to sample the benefits of organized medicine. CMS, she explained, is serving the needs and interests of residents and young doctors by forming special membership sections devoted exclusively to them. The Society is also offering young physicians additional seats on the CMS Council, including opportunities to participate on committees.

Dr. Bharati was accompanied by Immediate CMS Past President Shastri Swaminathan, MD, and Secretary William N. Werner, MD, both on staff at Illinois Masonic, and CMS Executive Director Ted Kanellakes; each spoke on the benefits of organized medicine. Following up on their advice, 25 residents signed on as members. CMS welcomes them aboard!

Chicago Medical Society

- Organized Chicago's first physician march through downtown Chicago, resulting in the temporary closure of approximately 20 street intersections.
- Facilitated a media campaign with coverage from Chicagoland television stations, radio stations and newspapers.

Physicians' Collective Bargaining Organization

- Served as executive vice president for one of five physician collective bargaining units in the country.
- Assisted with the development and facilitation of house staff organizations.
- Organized the country's largest resident house staff organization.
- Created and implemented a media campaign that received national coverage.
- Developed a strategic plan for implementing an improved resident benefit package, including better working conditions, higher wages, and resolutions for quality care issues.

"During his twelve years with CMS, Mr. Kanellakes has built a strong foundation for leading the organization into the future," said CMS President Saroja Bharati, MD. "Working for CMS and seeing it through its many changes over the years will enable Mr. Kanellakes to offer continuity and stability," Dr. Bharati continued. "More importantly, Mr. Kanellakes will be a driver of positive change, while upholding the guiding principles and vision of the CMS."





Medicaid Reporting Law

PASSING LEGISLATION IN SPRINGFIELD IS much like riding a roller coaster. A good example of the peaks and valleys of the ride can be found in the journey the ISMS Medicaid reporting bill took to become law.

HB 1628 passed in the General Assembly on June 13 and was promptly sent to Governor Blagojevich for his consideration. On Sept. 10, the Governor applied an "amendatory veto" to the bill, which would have stripped most of the intent of the proposal, but still allow portions to become law. With ISMS prodding, the House and Senate took action in October, voting unanimously to override the amendatory veto and allow the original bill to become law.

The new reporting law instructs the Illinois Department of Healthcare and Family Services to regularly update the General Assembly on the number of healthcare professionals serving in the Medicaid primary case management program; the number of participating physician specialists; and the number of individuals enrolled in the *All Kids* program. Local Senator, Jeffrey M. Schoenberg (D-Evanston), played a pivotal role in sponsoring and leading the veto override of this measure that will evaluate the effectiveness of these publicly funded programs.

Flu Vaccine Help

INFLUENZA VACCINE MANUFACTURERS ARE projecting an all-time production high with as many as 132 million doses of influenza vaccine available in the U.S. for use during the 2007-08 influenza season. ISMS maintains a Web page with information for physicians, including where to obtain vaccine supplies.

Medicare

LAST MONTH, ISMS MAILED A "MEDICARE crisis" poster to our members most likely to treat senior patients. The poster offers information to alert patients to the looming Medicare cuts, and tear-off sheets for them to take home and use in making contact with federal lawmakers.

CMS Members can call (800) 782-4767 or e-mail govt@isms.org for extra copies of the poster or tear-off sheets.

Despite expressions of support from both political parties, reversal of the 2008 Medicare funding cuts is not expected to arise for debate until year's end. The U.S. House of Representatives acquiesced to Senate demands to separate Medicare issues from the SCHIP (state children's health insurance program) funding renewal. Washington scuttlebutt: is it highly unlikely Congress will deal with the Medicare cuts until an agreement on SCHIP has been inked.

The AMA is asking doctors to continue to contact Congress (and especially our U.S. Senators), urging support for a two-year positive Medicare fix. Please urge your colleagues and patients to make these calls to Washington through the AMA patient hotline, (888) 434-6200. Congress is expected to recess in mid-November, which serves as an opportune time for physicians to set up district office appointments with lawmakers.

Women Physicians Forum

ON WEDNESDAY, OCT. 24, ISMS HOSTED 70 women physicians from the Chicago region for the 1st Illinois Women Physicians Forum event. The evening featured networking and remarks from ISMS member Joanne C. Smith, MD, CEO of the Rehabilitation Institute of Chicago. Similar events will be held in 2008 and all female members of the CMS are encouraged to participate.

Attention, students and residents! Educational loan update

THE AMA IS PUSHING FOR PERMANENT reinstatement of the 20/220 pathway, a program that enabled residents to delay repayment of their educational loans during residency.

The 20/220 pathway was eliminated Oct. 1 as part of the College Cost Reduction and Access Act. Under that program, residents qualified for economic hardship deferments on their loans--delaying payment on subsidized loans for three years without accruing interest--if their debt burden was greater than 20 percent of their income, and if their income was not greater than 220 percent of the federal poverty level.

After intense lobbying by the AMA, the U.S. Department of Education recently announced a temporary solution to extend the program until fall

2008, while allowing current participants in the economic hardship deferment to finish their remaining years of eligibility. And in early November, a bill to restore the 20/220 pathway and make it permanent--S. 2303--was introduced in the U.S. Senate.

Medical student and resident/fellow members of the AMA have been very active on this issue in recent weeks--including making phone calls to Congress, sending e-mail messages and speaking face-to-face with lawmakers. Student and resident activists have also been extremely effective in spreading the word among state and specialty societies, hospital staffs, colleagues at their institutions, and early career physicians.

AMA and AARP call on Senate to avert Medicare physician payment cuts

A JOINT TELEVISION AD FROM THE AMA and AARP began airing in October in select areas of the country and Washington, DC, to spur congressional action to preserve Medicare patients' access to health care.

In the joint ad, the AMA and AARP ask, "If doctors are forced to downsize their practices and Medicare premiums rise even higher, how will you get the care you need?"

The AMA and AARP are calling on the Senate to take action similar to the House of Representatives, which passed legislation to eliminate \$54 billion in excess payments to private insurers offering Medicare Advantage plans. Only one in five seniors is enrolled in Medicare Advantage, but these excess payments to insurers are coming out of everybody's pockets.

"By eliminating excess payments to Medicare Advantage plans, Congress can put the savings to good use to stop the next two years of Medicare cuts to doctors and instead update payments to help cover increasing costs, while limiting premium increases for seniors," said AMA Board Chair Edward L. Langston, MD.

Other elements of the joint effort include advocacy at the national level and a series of print ads

and opinion pieces in newspapers around the country.
