## TALKING POINTS

### ***Membership Talking Points you can use to recruit your colleagues***

#### **MISSION:**

The Chicago Medical Society (CMS) is a professional organization dedicated to assisting physicians in the practice of medicine. CMS' mission is: "To provide medical professionalism, medical education, public health, and to provide the highest level of assistance and information to our members."

#### **MEMBERSHIP:**

Representing over 17,000 physicians, CMS is one of the largest and most active county medical societies in the country. As a charter component of the Illinois State Medical Society (ISMS), you will also have access to its resources and the extensive expertise of its staff.

CMS and ISMS represent all physicians and continuously work together with other specialty societies to establish a unified front against the many obstacles we encounter in our profession. CMS and ISMS are the only organizations to provide a platform for physicians to speak with a unified voice. CMS offers physicians the opportunity to learn about trends in the practice of medicine through committee participation, policy development, educational seminars, and publications. In addition, membership provides networking opportunities, membership services, and advocacy.

Membership is open to all licensed physicians, medical students, interns, residents, and fellows who either live or practice within Cook County.

Our membership will be stronger and more effective with your active participation.

#### **GOVERNANCE STRUCTURE:**

The Chicago Medical Society is governed by its members through its Board of Trustees, Council, committees, and eight districts. This structure allows CMS to efficiently address issues affecting the healthcare delivery system.

Professional Development - CME-accredited educational programs, specifically relevant to the practice of medicine, are designed to help you hone your clinical and business skills.

CMS Insurance Agency, Inc. - The Chicago Medical Society developed the CMS Insurance Agency as a value-added benefit to the physician-members of Cook County. The CMS Agency assists CMS members with their professional liability insurance needs.

Public Health - The Chicago Medical Society, in conjunction with the Chicago Department of Public Health, is entering its 5th year in the Emergency and Public Health Preparedness program. The goal is to train physicians and other healthcare professionals and improve responsiveness in the face of a public health emergency or bioterrorism threat. This past year, CMS has educated over 550 healthcare professionals about the avian flu.

Legislative Breakfast Meetings - Over the past 12 months, the Chicago Medical Society has offered a forum for communicating with politicians through legislative breakfast meetings. These informal get-togethers allow members to voice their concerns to local leaders about legislation affecting the practice of medicine.

Public Health Information Rapid Exchange (PHIRE) System - The Chicago Medical Society and Centers for Disease Control and Prevention (CDC) invite practicing physicians to voluntarily register into a national Public Health Information Rapid Exchange (PHIRE) system which:

- Provides notification of critical care and health information.
- Tiers by severity (i.e., immediate action, guidance/surveillance, information, update).
- Disseminates directly to those who can act most expeditiously to preserve and protect our nation's health.

## TALKING POINTS *(continued)*

### Chicago Medical Society Publications -

- The monthly member newsletter informs of breaking news of interest to physicians, legislative and political developments, and CMS department and committee updates.
- The quarterly CMS magazine, *Chicago Medicine*, contains technical and general interest articles, legal and financial information, medical updates, district meeting updates, and other information.
- The annual CMS Reference Issue identifies the members of committees, districts, specialty societies, past presidents, CMS staff assignments, in addition to job opportunities and health-related contacts.

### Online Career Center -

Target your recruitment efforts with CMS and the HEALTHeCAREERS Network. The CMS Career Center enables members to create a professional resume and post it for potential employers to view. The Career Center also allows employers to conduct a national search for potential candidates.

- Chicago Public Schools is requesting that all students entering kindergarten and ninth grade have their new physical examination completed in order to be in compliance for the 2007-2008 school year before Oct. 15, 2007. In addition, all required immunizations must be updated.

# The Illinois State Medical Society and the Chicago Medical Society Recruiter Rewards Program



## Q & A

### *Q. What is the ISMS and CMS Recruiter Rewards Program?*

A. The Recruiter Rewards Program allows ISMS and CMS members to receive rebates on their membership dues through the direct recruitment of other physicians as members.

### *Q. How many members do I need to recruit and how much is the rebate?*

<b>2 New Members</b>	<b>15% Dues Rebate</b>
<b>3 New Members</b>	<b>30% Dues Rebate</b>
<b>4 New Members</b>	<b>50% Dues Rebate</b>
<b>5 New Members</b>	<b>75% Dues Rebate</b>
<b>6 or More New Members</b>	<b>100% Dues Rebate</b>

Note: Students and resident recruiters will be given gift certificates in lieu of rebates.

### *Q. Who is eligible?*

A. Those eligible as recruiters are individual physicians, groups with nine or fewer physicians, and groups of 10 or more physicians that do not participate in the Group Dues Program. ISMS and CMS officers and trustees are not eligible for this program.

### *Q. Who qualifies as a new member?*

A. For the recruiting member to receive the “dues discount credit” for a new member, all newly recruited physicians must:

- 1) Be dues-paying members; recruitment for a non-dues paying membership category is not counted towards a recruiter dues discount credit.
- 2) Be a first-time member or a reinstated member whose membership was not active for one full year.
- 3) Include the recruiting member’s name on their membership application.

Note: Physicians recruited after June 1 who pay half-year dues will not initially count towards their recruiter’s discount until they pay their full-year membership dues the following year. Once this payment is made, the discount for the recruiter will be applied towards the following membership year.

### *Q. Can I opt out of my rebate?*

A. Yes, ISMS and CMS member recruiters may waive their allotted discounts if they so desire, in favor of an equal amount contribution made in their name to the Illinois State Medical Society Political Action Committee (IMPAC)

- The Annual Midwest Clinical Conference, an extravaganza offering CME to the hundreds of physicians who attend each spring. Various sponsors, including pharmaceutical, financial, and insurance services actively support this community-based activity.
- Joint sponsorships including partnerships within the medical community, such as the one between CMS and the Center for International Rehabilitation, which recently developed and presented a very successful three-hour CME activity on “Humanitarian Relief Through Tele-Medicine.”

- Actively managing and securing CME for key specialty societies in Cook County, such as the Chicago Pediatric Society, the Chicago Gynecological Society, and the Chicago Neurological Society.
- Assisting with educational programs and special events planned by the Chicago Society of Internal Medicine, the Chicago Ophthalmological Society, the Indian American Medical Association, the Philippine Medical Association in Chicago, and the Polish-American Medical Society.
- Providing practice management sessions through our alliance with OSHA’s Chicago North Office, which offers workshops on potential occupational exposures, safety precautions, and current OSHA guidelines and standards. Participants consistently give this program high marks.
- Helping physicians develop their leadership through an all-day yearly “Parliamentary Procedures Workshop,” based on the Sturgis Rules of Order.

Through these educational activities, CMS has established itself as a highly reputable and quality-driven CME provider. Over the course of a year, CMS educates approximately 3,000 physicians, 400 other healthcare professionals (non-MDs), and thereby adds to its growing educational network of over 50 diversified healthcare organizations.



## ***Illinois Regulators Launch Online Physician Profiles, including Med Mal Histories***

AN IMPORTANT DEADLINE IS LOOMING FOR each and every Illinois-licensed physician. Nov. 15 marks the date by which all doctors must log on to the Web site of the Illinois Department of Financial and Professional Regulation to complete and check the accuracy of their individual physician profile.

Why? Because shortly after Nov. 15th, these profiles will “go live,” and be made available to web surfers worldwide (including patients, journalists, health plans, lawyers, and a host of others trolling for Web-based medical information).

Illinois is not the first state to take the profiling step. Massachusetts pioneered the concept more than a decade ago, and since then, many other states have enacted similar Web-based physician profiles for consumer access. Illinois lawmakers insisted on profiling as part and parcel of the 2005 legislation on the medical litigation reform package. ISMS vehemently opposed its inclusion, but the provision was added to the bill despite our objections. At the time, the ISMS Board gave our members a “heads-up” on the profiling provision, but in the intervening two years, this obscure but important part of the law has garnered slight notice.

Now, some two years later, the IDFPR is scurrying to implement the profiling law before year’s end. All Illinois licensed doctors will receive (and in fact should have already gotten) a letter instructing them to log on to the state agency’s Web site and update their profiles no later than Nov. 15. Profiles must be completed online—verbal and written information will not be accepted. Once you have reviewed and completed your physician profile update, you will receive a confirming e-mail from state regulators.

The accuracy of your profile depends on your review! In addition to general information on medical education and specialty, hospital affiliations, insurance plans accepted, and office hours and addresses, the site will include a listing over the last five years of all medical disciplinary actions, felony and misdemeanor convictions, and hospital privilege restrictions.

**It is vitally important that individual physicians log-on to check their medical malpractice histories and other data the agency has inserted**

**about them, as well as provide other desired information. Fines and penalties may accrue to those who fail to do so.**

ISMS has gathered a host of resources to assist members with questions about physician profiling. We have instituted a dedicated hotline to answer members’ questions, or physicians can e-mail us with questions/concerns.
