Guest candidates make election-year push

JILL MORGENTHALER, ILLINOIS DEMOCRATIC candidate for the sixth congressional district, and Steven Sauerberg, MD, Illinois Republican candidate for the U.S. Senate, spoke before the Sept. 9 Council meeting, held at Maggiano's Banquets. This was the second visit by each candidate to CMS recently. They spoke about their backgrounds and goals for health care and took questions from the audience.:

- Along with a military career that began in 1976, Jill Morgenthaler has 30 years' experience in the private sector and government. She served as Illinois' Homeland Security Advisor from 2005-2007, after leaving Argonne National Laboratory, where she worked in various capacities for 14 years. Ms. Morgenthaler has worked with doctors and suffered her own family health crises, experiences she believes help her to understand the problems facing many Americans. Ms. Morgenthaler pledged to focus on changes that would allow doctors to do their jobs, promising to encourage dialogue among insurers, patients, providers, and legislators.
- **Dr. Sauerberg**, a family physician from La-Grange, told physicians that they must match the donations the trial lawyers give to their professional organizations, in addition to aggressively supporting their colleagues who run for office. With so few doctors in Congress, it's imperative that physicians get involved if they want to be part of health care reform, he said. Dr. Sauerberg called the current system "fundamentally

flawed," and believes that getting rid of defensive medicine is the way to go. He called for special health panels to decide malpractice cases and for "loser pays" to apply in cases that go to the state judicial system.

AMA OFFICIAL NAMED HONORARY **CMS** MEMBER CMS awarded honorary membership status on Jeremy Lazarus, MD, a Colorado psychiatrist and

speaker of the AMA House of Delegates.

A grateful Dr. Lazarus called it a "great, great humbling honor" and remarked how much he'd learned as an AMA Board member about respecting different points of view among his colleagues.

Dr. Lazarus reviewed the AMA's agenda for the next year. Priorities include:

- Expanding membership through more services and advocacy.
- Lobbying for a better Medicare payment structure.
- Reforming the health system, particularly for those who are uninsured.
- Changing anti-trust laws so that physicians can integrate clinically.

A Chicago native, Dr. Lazarus attended Northwestern University and the University of Illinois College of Medicine. He was re-elected speaker of the AMA House of Delegates in June 2008, after having served as vice speaker from 2003 to 2007. He currently serves as chair of the AMA Board of Trustees Task Force on Quality, Safety and Electronic Health Records and as a member of the AMA-BOT Executive, Membership and Compensation committees. He is one of the AMA's chief spokespersons on the uninsured.




The Society urges a full CMS delegation at the ISMS House of Delegates meetings. Delegates and alternates are being asked to make early arrangements and confirm them with staff.

IMMEDIATE PAST PRESIDENT CONTINUES ADVOCACY

Dr. Saroja Bharati has continued her activities on the Society's behalf this summer. She partici-

pated in the following events: Chicagoland Chamber of Commerce, Environmental Law & Policy Center; Chicagoland Chamber of Commerce, Healthcare & Wellness Committee Meeting; and the Building a Healthier Chicago, Nutrition Conference Planning Meeting.

ISMS ADVOCATING ON YOUR BEHALF

ISMS President Shastri Swaminathan, MD, provided the following update:

- ISMS was extremely active in reaching out to the Illinois Congressional delegation, urging representatives to roll back the SGR cuts. Organized medicine had a great victory and physicians should be proud that the coalition of medical societies (led by the AMA) overcame Washington gridlock to enact legislation. Future efforts must be directed toward scrapping the SGR. ISMS stands ready to assist AMA in this important policy priority.
- ISMS has prepared an Rx for Good Health handout for patients, encouraging them to form partnerships with their doctors.
- ISMS and CMS are hosting an inaugural program for graduate medical education directors on Saturday, Dec. 6, at the University Club. An expert speaker will discuss new issues and trends in GME, and a roundtable forum for participants will address how organized medicine in Illinois can better serve them.
- The General Assembly approved legislation that began as a CMS resolution from District 6 to establish a Health Policy Center based at the University of Illinois. In mid-August, Governor Blagojevich issued an amendatory veto of this legislation—and called for changes that would require UIC to consult with and seek the participation of all other public universities and would add four additional members to the advisory panel implementing the law. ISMS remains hopeful that the veto can be addressed during the General Assembly's upcoming post-election veto session, and that this important bill can become law.

ISMS ASKED TO STUDY REDUCING MEMBERSHIP DUES

Would reducing dues or adding new membership categories result in additional CMS members? After studying the Society's membership categories and dues structure, the Membership Com-

mittee and Council voted to ask the ISMS leadership to look into this possibility. ISMS will be asked to create a Membership Presidential Ad Hoc Committee to investigate the multi-faceted issue of reducing membership dues as a way to grow the membership.

RESOLUTIONS CONSIDERED

- Liability Requirements by the Hospital Administration—CMS reaffirmed existing policy supporting the right of physicians to determine whether to carry liability insurance and at limits they choose.
- Establishing a CMS Senior Physicians Group Section (SPGS)—The Council voted to forward this initiative to the Long-Range Planning Committee to study the feasibility of establishing within CMS sections that would represent various blocks such as young, women, and senior physicians.
- Encouraging "Green" Initiatives—The Council

voted to encourage green initiatives within the state of Illinois and further encourage comprehensive efforts to teach children how to live on a planet with finite resources; to support efforts to encourage companies, manufacturers, and public school systems to curtail greenhouse gas emissions and recycle materials and resources; and to support the Illinois delegation in bringing a similar resolution to the AMA's annual meeting.





Liability reform law under siege: fate in hands of court

THE CONSTITUTIONAL CHALLENGE TO ILLINOIS' comprehensive and landmark 2005 medical liability reform law continues and the statute's fate is now in the hands of the Illinois Supreme Court. The latest attacks to the law came in the form of legal briefs from the anti-reform camp. Trial attorney and related legal groups offered their arguments for why the liability reforms should be overturned. The parties supporting the law (including ISMS and the AMA) are now given a final chance to respond to the trial lawyers with our own set of briefs, for what could be the last step before the Supreme Court sets a date for oral arguments to occur.

The earliest oral arguments could possibly be slated is October, but it is conceivable arguments may not be scheduled until some time in 2009. Procedurally the high court has wide discretion for scheduling such matters.

As we watch the challenge proceed in the courts, ISMS strives to keep the spotlight shining on why the reform law is so important for Illinois. In partnership with ISMIE Mutual, ISMS has been busy with the *Reality Medicine* education initiative. The following represents a sampling of what we've done lately to keep our message before the public.

- In August, Illinoisans attending the State Fair received a dose of *Reality Medicine* at the ISMS/ISMIE booth. Fairgoers received information about medical liability reform and helpful summer health items.
- During the Labor Day holiday weekend a small plane carried a large banner message calling to *Keep Doctors in Illinois* over the Chicago lakefront. Hundreds of thousands of people saw this important message.
- ISMS President Shastri Swaminathan, MD, took on the president of the Illinois Trial Lawyers Association (ITLA) during two summertime debates on WLS and WBBM radio. Dr. Swaminathan delivered the facts for why keeping medical liability reform is a must for Illinois. You can listen to both debates online at www.isms.org.
- Keep Doctors in Illinois billboards began appearing throughout Illinois over the summer. Several

- of the billboards can be found in the Chicagoland region at high traffic/visibility areas.
- *Reality Medicine* "Radio Check-Ups" continue to play on Chicago airwaves. The informative radio spots link important health issues to medical liability reform.
- ISMS members received special "Rx style" pads with tear away sheets carrying the medical liability reform message.





FDA approves 2008-2009 flu vaccines

THE U.S. FOOD AND DRUG ADMINISTRATION has approved this year's seasonal influenza vaccines that include new strains of the virus likely to cause flu in the United States during the 2008-2009 season.

The six vaccines and their manufacturers are: CSL Limited, Afluria; GlaxoSmithKline Biologicals; Fluarix; ID Biomedical Corporation of Quebec, FluLaval; MedImmune Vaccines Inc., FluMist; Novartis Vaccines and Diagnostics Limited, Fluvirin; and Sanofi Pasteur Inc., Fluzone. Approval information and specific indications can be found at http://www.fda.gov/cber/flu/flu2008.htm.

The FDA changed all three strains for this year's influenza vaccine—an unusual occurrence, as usually only one or two strains are updated from year to year. A list of the strains included in the 2008-

2009 vaccine can be found at the above email address. Of note, two of the three strains recommended for the U.S. this year are now in use for the Southern Hemisphere's 2008 influenza season, which is currently underway.

Each year, experts from the FDA, World Health Organization, U.S. Centers for Disease Control and Prevention, and other institutions, study virus samples and patterns collected throughout the year from around the world in an effort to identify strains that may cause the most illness in the upcoming season.

Based on those forecasts and on the recommendations of its Advisory Committee, the FDA each February decides on the three strains that manufacturers should include in their vaccines for the U.S. population.

Do you owe the IRS any overdue Federal Payment Levy Program Taxes?

IF YOUR ANSWER TO THE QUESTION ABOVE is yes, as of Oct. l, 2008, your Medicare reimbursement check may be subject to a levy of 15% (or the entire amount you owe in taxes, if the amount is less than 15%). Your Medicare remittance advice will list code "WU" in the PLB03-1 data field with a toll-free phone number.

Each time a federal tax is levied, you will receive a letter of notification with advice on whom to contact if you wish.

Under present privacy rules, only the IRS may discuss your tax issues; consequently, Medicare will not discuss your payment reduction.

The Treasury Department's Financial Management Service and the IRS passed regulations in July 2000, which are authorized by the Internal Revenue

Code Section 6331 (h) as prescribed by Section 1024 of the Taxpayer Relief Act of 1997. A continuous levy is authorized for the collection of overdue taxes from certain vendors and contractors.


